

# **GDPR PRIVACY POLICY**

This privacy policy outlines how we, the organizers of the Orston Spring Dash run, collect, use, and protect personal data that is provided to us by participants during registration. We are committed to ensuring that your privacy is protected and that we are in compliance with the General Data Protection Regulation (GDPR) and any other applicable data protection legislation in the UK.

#### **Data Controller**

#### What personal data we collect

We will collect the following personal data from participants during registration:

- Name
- Address
- Date of birth
- Gender
- Contact information (telephone and email)
- Any relevant medical information that may affect participation in the event

We will only collect the minimum amount of personal data necessary for the purposes of administering the event and ensuring participants' safety.

## How we use your personal data

We will use the personal data collected during registration for the following purposes:

- To administer the event, including communication with participants before and after the event
- To ensure participants' safety during the event
- To share your name and finishing time with RunBritain and on the event website
- To comply with any legal obligations

We will not use your personal data for any other purposes without obtaining your consent first.

## Legal Basis for Processing Personal Data

The legal basis for processing your personal data is to fulfill our contractual obligations to you as a participant in the event. In addition, we have a legitimate interest in ensuring participants' safety and complying with legal obligations.

#### **Data Retention**

We will retain your personal data for a maximum of 4 years after the event. After this time, your personal data will be securely deleted or anonymized.

#### Disclosure of Personal Data

We will only disclose your personal data to third parties if it is necessary for the administration of the event or if required by law. For example, we may share your personal data with our event timing provider or with emergency services if necessary.

#### Security of Personal Data

We are committed to ensuring that your personal data is secure. We have implemented appropriate technical and organizational measures to protect your personal data against unauthorized or unlawful processing, accidental loss, destruction, or damage.

# Our use of cookies and other information-gathering technologies

Cookies are text files placed on your computer to collect standard internet log information and visitor behaviour information. The information is used to track visitor use of the website and to compile statistical reports on website activity.
